# **OUR HISTORY**

May 23, 1915	St. Luke's church constitution is adopted. This is the first record of St. Luke's Lutheran Church.	
April 2, 1944	The congregation became self-supporting and was no longer subsidized by the Kansas District.	
December 10, 1949	The mortgage is paid in full.	
April 19, 1953	A new Church building was dedicated on land purchased on the corner of Sunset and Delaware.	
October 5, 1961	The St. Luke's educational facility is dedicated.	
1981	A preschool for three- and four-year old children is started.	
1987	B.A.S.I.C Training (Brothers and Sisters in Christ) began.	
2002	Congregation purchased 28.16 acres of land on West Anderson Avenue.	
October 2, 2011	Reverend Michael Schmidt is installed as St. Luke's pastor.	
2015	The preschool is converted to an Early Learning center.	
2016	Congregation votes to move forward with plans to build on West Anderson Property.

# **FAOS**

Why are we doing this again, we did it 20 years ago? We have held campaigns and fund raising efforts in the past and those efforts have been successful. Thanks to the generosity of earlier giving, these dollars have been set aside and will be used for this project. Some of the dollars have been spent for land purchase, architects, etc. to get us where we are today. Unfortunately, we have not raised enough in past efforts to fund the project and thus we are hosting another capital campaign with the goal of building on our site and begin holding services and meeting on it.

I gave the last time; do you expect me to give again? We appreciate your past support and believe we have invested your dollars wisely. Our new campus on our Anderson Avenue site will happen because we all believe in the future of St. Luke's and the continued good work that we accomplish as a church family. We understand you have given before, but we hope that as a family you will talk about it, pray about it, and see the need for us all to continue coming together to financially support this important endeavor. Churches grow and thrive because of giving members who are unselfish with their time, their talent, and their dollars. Your continued and renewed support would be much appreciated.

I don't want to give until ground is actually broken - then I will know it is actually **happening.** We understand your concern, as many of us had hoped we would be in our new facilities, at our new site by now. The leadership is working very hard to make this a reality at this time and believe it will happen if the congregation will also believe and join in our efforts. Waiting to

see if it will happen, will not allow it to happen. In order for us to sign contracts with contractors, we have to have cash and pledges to show signs of good faith for them to work with/for us. Your pledge commitments will allow us to keep moving ahead and make St. Luke's dream a reality.

# How can we afford this project when we have trouble meeting our annual budget?

We have conducted a feasibility study by a professional consultant and voted as a church membership to go forward. We believe that it can be successful based on the results and the past support of our members. We are hopeful that our members will see the needs and benefits of this campaign and continue to financially support St. Luke's with their ordinary giving for the annual budget, but also support the campaign with their extraordinary giving.

### Why did we hire a campaign consultant?

Campaign consultants bring experience, knowledge, and a sense of urgency to a campaign. As a church that is managed by volunteers we needed this piece to keep our project moving and for success. Research has proven that hiring a consultant raises more money (they are a good investment), will save us time and effort, and will make it more than a campaign, but an opportunity to grow closer as a church community. We believe this is a worthwhile expense, as we all want this to be successful as we work hard to fulfill our vision.

What is the timeframe for the capital campaign? A campaign committee has been established and is working on the campaign. Over the next few months, you will see more information including ways you can volunteer, ways you can give, and ways you can support the

campaign to enhance St. Luke's. Sunday, April 29 is designated campaign Sunday. Home visitors will be assigned to each parishioner's home to deliver and pickup (at a later date) the gift commitment form. Families will be asked to think about, talk about, and pray about their campaign gift. Giving will be done confidentially through a sealed envelope process and there will be no pressure to make a gift.

Can we make pledges? Campaign gifts can be made over a 3-year period and sent in weekly, monthly, quarterly, or annually. Appreciated assets or noncash gifts may be made by contacting the church office. If a financial commitment cannot be made at this time, we ask that you support the campaign through prayer.

It is through prayer and the desire to continue the good work of St. Luke's that those that came before have accomplished through our rich history that will make this happen. It is our turn to give and continue our history of growing our Lutheran faith and community.
